POOCH PAD KENNEL BOARDING AND DOGGIE DAY CARE'S RESPONSIBILITIES

Pooch Pad agrees to exercise due diligence and reasonable care in maintenance of the kennel property and facilities, striving to maintain a sanitary premises and well-maintained fences and kennels. Pets under the care of Pooch Pad will to be fed properly and will be housed in clean, safe quarters. Pooch Pad will always strive to ensure the safety of your pet.

PET OWNER'S RESPONSIBILITIES

Owner agrees to fully disclose any known health or temperamental issue that the pet has, or disclose any other relevant issue that owner has reason to know about pet. This includes any previous history of aggression, self-damaging tendencies, or any other issue that the owner feels would help Pooch Pad ensure the safety and health of pet and all other animals boarded on the premises

Owner will regularly have pet examined by a veterinarian and must be up to date on all required vaccinations and shots. Pooch Pad suggests that pet be examined for intestinal parasites through fecal examination. Proof of required vaccinations must be provided upon request.

If pet is on any medication, it is *owner's sole responsibility* to inform Pooch Pad of this fact and provide Pooch Pad with sufficient amounts of medication, with detailed directions of times and manner of administration. Additionally, if the time and/or manner of administration of the medication ever changes, it is the sole responsibility of owner to immediately inform Pooch Pad of such change. If while following the directions of owner, any side-effect or injury that occurs as a result of Pooch Pad's administration of the medicine to the pet, the injury will not be the responsibility of Pooch Pad or the employees thereof. However, Pooch Pad will exercise due diligence and reasonable care in obtaining emergency care for pet if such situation should occur.

FLEA AND TICK POLICY

In order to ensure the safety and health of all of the pets under the care of Pooch Pad, it is necessary to have every pet free of external parasites, including, but not limited, to fleas and ticks. Because of this need, Pooch Pad employs a rigorous 4 step procedure to control fleas and ticks.

In the event pet is boarded at Pooch Pad and is found to have external parasites, they will be immediately removed by any means Pooch Pad deems necessary, *at Owners cost*. In order to avoid the extra costs of external parasite treatment, owner agrees to have pet treated monthly for external parasites at a veterinarian. If owner elects to have Pooch Pad treat the external parasites, owner will inform Pooch Pad upon admittance.

FEES AND COSTS

Owner understands and agrees that they will be charged for a full day of boarding regardless what time pet is dropped off. As pick-up time is noon, owner will also be charged an additional day for pets picked up after noon on scheduled day of pick up. Owner understands that they will always be charged on Sunday's regardless time of pick up. Owner understands late charges will be charged for pets picked up after regular business hours. Owner understands they will be charged \$.50 per pet, per time medication is administered.

Owner agrees to pay the rate for boarding in effect on the date pet is checked into Pooch Pad. And further agrees to pay all costs and charges for special services requested and all veterinary cost for the pet during the time said pet is in the care of the Kennel.

Owner understands any and all deposits made for kennels or dog suites will be forfeited upon cancellation of reservation regardless notice was given.

EMERGENCY SITUATIONS

If your pet becomes ill or if the state of the pet's health otherwise requires professional attention, Pooch Pad, in its sole discretion, may engage the services of a veterinarian of its choosing, administer medicine, or give other requisite attention to the pet. The expenses for such professional attention and care shall be paid by owner. This includes needing the proper vaccinations. It is also the **owner's sole** responsibility to inform Pooch Pad of any veterinarian changes and any vaccination updates. It is also the sole responsibility of the Owner to keep us informed of any medication changes or amounts.

LIABILITY

Pooch Pad does not assume and shall not be held responsible for any liability with respect the animal listed in this agreement, of any kind, character, or nature whatsoever, arising out of or from boarding this animal, or any damages which may accrue from any other cause whatsoever including loss by fire, theft, running away, death, injury to persons, animals, or property, or death or injury to any other animal caused by the within named animal during the term of this contract, whether this animal be on the premises of Pooch Pad or not, and the owner of said animal agrees hereby to be and is solely responsible for any and all acts of behavior of said animal at any time within the term and time of the contract.

The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of Pooch Pad, to include payment of cost for injury to staff or other animals or damage to facilities caused by the pet.
